

# BECKINGHAM-CUM-SAUNDBY PARISH COUNCIL

## Grant Awarding Policy

### Grants Background

The Local Government Act 1972 section 137 makes provision for Parish Councils to provide financial support, up to a fixed amount, for the benefit of residents of the Parish. The total annual amount available to a Parish for this purpose is prescribed by Government and is a 'resident rate' times the number of residents on the Parish Electoral roll. The resident rate is linked to the Retail Price Index.

### Objective:

It is the Parish Council's objective to ensure that any grants it awards is for the greater benefit of its residents and the community.

### The Policy:

#### S137 Limit

The Clerk will keep the Council informed of the current annual S137 limit.

### Grant Application Requirements

- 2.1. Applications for grants will **not** be considered unless the [Parish Council's Grant Application](#) form has been completed.
- 2.2. Applications for grants can only be considered from organisations whose work benefits the Parish and its residents.
- 2.3. Applications from individuals **cannot** be considered, nor can applications where the grant would benefit an individual.
- 2.4. Applications for retrospective grants, where a project has already been completed, cannot be considered.
- 2.5. **All** applications **must**, provide copies of the applicant groups most recent **three** bank statements, for **each and every bank account** held, in support of the application. All applications **must also provide** a statement of the most recent audited accounts.
- 2.6. The Council will only consider one grant application per organisation per financial year unless there are extenuating circumstances.
- 2.7. Grant applications may be considered at any time of the year, funds permitting
- 2.8. All grant applications will be considered and applicants will be informed of the Councils' decision, grants will **ONLY** be issued by successful applicants by BACS, **not** by cheque.
- 2.9. The decision on the grant being awarded is at the discretion of the Council whose decision shall be final.

### Grant Allocation

- 3.1. Total Grant Fund - The total sum available for all grants varies year upon year but is included in the budget setting process which is completed each January for the following financial year.

- 3.2. Maximum per Application - The Council will not consider a single grant application which exceeds £1,000 unless there are extenuating circumstances and all other approved grant applications can be satisfied.
- 3.3. Minimum per Application - The minimum amount that can be applied for is £25.
- 3.4. Grant Fund Shortfall - Where the total value of all grant applications exceeds the available funds and the Council considers the applications of equal merit, the Council may offer a reduced grant to applicants.

### **Ongoing Grants**

Repeat applications for grants year upon year will not be considered, unless there are exceptional circumstances which the Council considers an appropriate use of its grant fund. For example, the need to prevent a worthwhile project from stalling or failing and other funding is not available. Such grants cannot exceed three years unless the applicant can demonstrate that other attempts at funding have been made. Grants will not be made for ongoing routine maintenance and operating costs of a group, charity or body.

### **Grant Spend**

- 6.1 Proof of Spend - A recipient of a grant **must** provide evidence of how the grant was spent in the form of a written report, supported by financial evidence where available. The report must be received by the Clerk within 12 months of receipt of the grant. The report will become a document available to public inspection under the provisions of Section 228 of the Local Government Act 1972 (as amended).
- 6.2 Acknowledgement of Grant - Recipients of grants may be asked to acknowledge the Parish Council's support on promotional material, press releases and/or stationery if appropriate.

### **Grants Policy Distribution and Maintenance**

- 7.1 The Clerk will retain the master copy of the policy.
- 7.2 Copies of this policy will be distributed to all Parish Councillors.
- 7.3 A copy of this policy will be given to all grant applicants.
- 7.4 The policy will be reviewed annually.
